Sl. No.	The school is directed to ensure that :
1	The total number of sections of the school shall be restricted to 20 and further increase of sections shall be subject to specific approval of the Board on the basis of

	the request of the school as per affiliation bye law subject to availability of class rooms of greater than 500 sq ft dimension
2	Safety features like separate entry and exit, exhaust fans and fire extinguisher are not seen in the composite lab. the school shall upgrade the lab as per SoP issued by the Board within 3 months and submit compliance on SARAS with videography.
3	The library is seen as under stocked. no separate reading area for staff is seen. the school shall upgrade the library as per Sop issued by the board within 3 months and submit compliance on SARAS with videography.
4	The school has converted regular cubicles into CWSN toilets which are too small and narrow for wheelchair/walker to enter and navigate. the school shall construct separate toilets for CWSN, boys and girls on every floor with proper permanent signage, indicating the floor number, as per norms of RPwD Act and guidelines issued by the board within 3 months and submit compliance on SARAS with videography.
5	The school has submitted the fire safety certificate of the main school building, whereas it has other blocks in the campus. the lab block is separate and not covered in the fire safety certificate. the school shall submit a fresh fire safety certificate including all the building blocks in the campus within 3 months and submit compliance on SARAS.
6	The campus at the back and sides is seen as overgrown with weeds and bushes and is not deemed safe for students. The toilets area needs improvement. Many WCs are seen as dirty and broken. The school shall clean up the overgrown campus area and ensure renovation and cleanliness in toilets within 3 months and submit compliance on SARAS with videography.
7	The school shall conduct training of its teachers with CoE Vijayawada within 3 months and submit the compliance.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.

The approval of the Board as mentioned above, is subject to the following conditions:-

1. The school shall be responsible for its genuineness of the documents/ data/ information uploaded by the school. In case of any discrepancies, action will be initiated against the school as per Affiliation Bye -Laws-2018.
2. The school shall follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
3. The School shall apply online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
4. The school shall go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy thereof for reference purpose and is also advised to

regularly visit CBSE websites i.e., <http://cbseacademic.nic.in/> & <http://cbse.nic.in/> for updates.

5. The school shall renew mandatory certificates from time to time.
6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
7. Concerned Regional Office is requested to create new email id of school as per direction issued by controller of examination. This E Mail ID is used for communication with CBSE only.
8. The school shall not remove the documents and videography links in the mandatory disclosure section of its website.
9. The school shall follow the SOPs of the Board for its Laboratories, Library and sports facilities issued by the Board vide circular no 11 dated 04.10.2022.
