

MEMORANDUM OF THE SOCIETIES

1. **Name of the Society** : FAITH WELFARE SOCIETY

2. **Location of the office situated:** Plot No.2,
H.No.13-6-434/B/2 Light house, Om Nagar,
Hyderabad - 500008.

3. **AIMS AND OBJECTS** :-

- i) To establish homes for the poor children, widows and old age homes
- ii) To care the poor and needy backward people in rural & slum areas by establishing and maintained charitable institutions and it is a non-profitable organisation of entire India
- iii) To include moral and spiritual values in children youth women and all people through various methods of teachings.
- iv) To build prayer and meditation centres, Community halls libraries, health centres, and other multipurpose halls that help the community.

1. **Name of the Society** : FAITH WELFARE SOCIETY
2. **Location of the office**: Plot No.2, H.No. 13-6-434/B/2 Light house, Om Nagar, Hyderabad - 500

i) JURISDICTION :- Its Jurisdiction shall be extended to the whole of India till and otherwise decided upon by the General Body

3. **i) MEMBERSHIP :-** The Society shall admit 2 kinds of members ordinary members and life members. The period of the membership shall be the Financial Year.

ii) CATEGORY MEMBERS :- Ordinary membership shall be opened to those who pay Rs100/- as Annual subscription and who in the opinion of the Executive committee and subscribe to the objectives of the society and who are above eighteen years of age

iii) The Life membership shall be opened to individual, organisations / associations and who in the opinion of the executive committee and subscribe to the objectives of the society and who enrol themselves at a subscription fee of Rs. 1000/- per annum

iv) Annual dues of the members shall be for the financial year and shall be for the financial year and shall be payable by April 15th, to the each year

v) To executive committee shall have the right to remove any member for activities prejudicial to the objectives of the Society after giving such a member an opportunity to showcase against such removal

4. GENERAL BODY :-

i) Annual General Body will meet once in a year i.e., in the month of March

ii) FUNCTIONS: -

a) To pass the budget for the ensuring year and approval the expenditure statement of previous year.

b) To approve the report of the activities of the Society.

c) To elect the executive committee etc

d) To appoint an Auditor.



5. I) EXECUTIVE BODY :-

i) The exact number of executive body including office bearers is SEVEN President, Vice President, Secretary, Joint Secretary, Treasurer, Advisor, and 2 executive members

ii) The Executive Committee shall meet at least once in six months

iii) The Executive body term is 2 years from the date of election.

II) Functions of the Executive body and Office Bearers:-

i) PRESIDENT: - He presides over all the meetings of the both general body and executive committee. He can cast vote in the position. he can supervise all the branches of the Society.

ii) VICE PRESIDENT : -He will assist the President in discharging his functions, In absence of the President, he will perform the duty of the President as entrusted by him

iii) SECRETARY :-He is the Chief Executive Officer of the Society and custodian to all records relating to the Society and Correspondent on behalf of the Society. He has to take on record of all minutes of the Society to convey both the bodies of the society with the permission of the President He Guides the Treasurer in preparing the budget and expenditure statement to put before the general body for its Approval.

iv) JOINT SECRETARY:- He has to do the work as entrusted by the executive committee. He has to assist the Secretary in discharging his duties. In the absence of the Secretary he can perform the duties of the Secretary.

v) TREASURER:-He is the responsible person of all the Financial transactions relation to the Society. He has to maintain accounts properly along with the vouchers. He has to prepare budget expenditure statement of the Society with the guidance of secretary. He has to operate the amount of the society jointly with the Secretary and President.


vi) OFFICE BEARERS:- They are the responsible persons in doing the activities of the Society which the executive committee entrusted to them.



6. QUORUM:- The Quorum for the General Body and the Executive Body meetings shall be half of the numbers.


7. FUNDS :-

- i) Funds for the society shall comprise of subscription from ordinary members and life members in the form of membership fee Funds will also comprise of Donations, Contributions, gifts offering grants, etc. given either voluntarily or on request by individuals and governmental organisation within the country or abroad.
- ii) President and Secretary has powers with prior permission of the Exclusive committee to raise funds by the way of donations, subscriptions, benefit shows and such others.
- iii) The funds of the society shall be utilised for the benefit and improvement of the society and shall not otherwise utilised.
- iv) The funds of the society shall not to be paid or transferred directly or indirectly to any of its member's means.
- v) The exclusive body can avail loan(s) from the banks or other Financial institutions on movable properties or on immovable properties of the purpose for the purposes of the society.
- vi) The executive committee can buy and sell properties movable or immovable as and when required by the society to fulfil its objectives and the same should be registered in the name of the society represented by its Secretary or any other office bearer or Director as authorised by the executive committee. The money received at the time of the sale should be credited into the society accounts only.



8. **AMENDMENTS** :- No Amendments or Alterations shall be made unless it is voted by the 2/3rd of its members presented at a special meeting convened for the purpose and confirmed by 2/3rd of the members presented at the 2nd special meeting.
9. **WINDING UP** :- If the Society ceases to function and is dissolved at any time, the Assets remaining after settlement of all its Liabilities may subject to the approval of the general body be handed over to any other society with similar objectives. If the executive committee of the society does not take any initiative to do so., any member of the society shall be entitled to inform the matter to the Government of Telangana who shall then do the needful for the proper management of the Assets reaming.
